

- Adrene Wike New Manager
  - Introduction
- Britnee Johnston's Departure
  - Director of communications for the City of Draper
  - At this time we are not replacing the position
    - Reconsider post quarantine
- Vincent Brandon
  - Originally hired as a temporary designation as his position was funded purely from the SLDS grant
  - Due to the fact that Utah did not receive the SLDS 2019 grant, the position was no longer funded beyond September 2020
  - Administrative decisions were made to allow for Vincent to be permanent position
- UDOH data
  - Fully integrated into the UDRC
  - Full historical file to be communicated in the near future
  - Incorporating familial connections into the MPI process
    - Very useful for future research

- Next step:

    - UI enhancements
    - Export application
  - What has been completed last quarter:
    - Processed several new data files
    - Quality of life warehouse changes
    - Addition of SSID to deterministic matching algorithm
    - Validation and filtering of raw data pre-Matching
    - Consolidated DI's (manually merging multiple tables)
    - Enhancements to the Researcher Application wizard
    - Began research on moving to the Cloud
    - Modules on the filtering and merging services
    - · Workflow conceptualization, design, and requirement gathering
  - What we are working on this quarter:
    - UDRC Workflow 2.0
      - · Complete revamp of the UDRC process flow to integrate filtering and merging
      - Integration of additional functionality and UI enhancements
  - What is included in the April 15<sup>th</sup> deploy:
    - Many UI enhancements for the admin application:
      - We could not see the IRB determination information on the application
      - Could not see full address on the application summary
      - Had an issue when downloading the proposal
      - Six other items



### Kelsey Martinez

#### **UDRC RA4**

**Name**: Post-Secondary Enrollment and Migration in Utah

**Summary**: Following high school graduation, students are faced with two choices: 1) whether or not to enroll in a post-secondary program, and 2)

if they do choose to attend, whether to attend an institution near or far from their homes...

**Current Status of Project**: Completed internal review process on 4/13/2020. Will be sent to partners (UTech, USHE, and USBE) for review shortly

**Next Steps:** Prepare .csv files for data narrative, complete changes required by partner feedback/EDO, format for publication

#### **UDRC IA5**

Name: Impacts of Intergenerational Poverty or Workforce Metrics (IGP 2020 DWS report)

**Summary**: Ultimate goal of this research is to understand how IGP impacts peoples' abilities to successfully build a career or maintain gainful employment over a period of years...

**Current Status of Project**: I am almost finished with the linear models/analysis for this project. A draft of the introduction, literature review, and methods is complete.

**Next Steps:** Complete data cleaning and analysis in R, write results, discussion, and conclusion sections.

#### **UDRC RA5**

**Name**: Course-Taking Patterns and Post-Secondary Outcomes

**Summary**: The two objectives of this project are to analyze high school course-taking patterns and determine their effects on college readiness, and to determine if CTE participants continue on the intended educational pathway after high school.

**Current Status of Project**: First draft of report is being compiled for internal peer review

**Next Steps:** Internal peer review process, making necessary revisions to report.

#### **UDRC IA4**

Name: School Outcomes for Child Care

**Summary**: The two objectives of this project are to determine if the educational performance of children who received child care subsidies are similar to the general student population (3rd and 8th graders, 2003-2010), and to see if there is a marginal effect of additional child care, within the sample group, in relation to the outcome metrics.

**Current Status of Project**: Literature review is being completed, pre-proposal is being compiled.

**Next Steps:** Pre-proposal to be submitted for approval.

#### **UDRC RA6**

**Name**: Increased Spending From Post-Secondary Graduates in Utah (2011-2018)

**Summary**: The objective of this study aims to understand the differences of income and consumption among individuals of varying educational attainments in Utah (2011-2018)

**Current Status of Project**: Project is currently being prepared for its final draft

**Next Steps:** Dashboard creation and publication

#### **UDRC RA7**

Name: Gender Wage Discrimination of Postsecondary Graduates in Utah (2011-2019)

Summary: A study examines the wage differences from recent USHE and UTech graduates by gender. Results will be decomposed by human capital measures, and statistical models will be implemented to understand the significant variables of wage differences

**Current Status of Project**: Wireframe of paper is being written as well as variable selection

**Next Steps:** Data pull and cleaning of selected variables for analysis
